

# CELTICS REWARDS RULES SUPPLEMENT

The following Boston Celtics Rewards Rules (these “Rules”) are provided to holders of the Boston Celtics Cardless credit card issued by First Electronic Bank (“Celtics Cardholders”), and supplement the terms that govern the Cardless rewards program made available to Celtics Cardholders ([the “Program”](#)) and the associated Cardless rewards account. These Rules govern the use of all Boston Celtics-related rewards made available to Celtics Cardholders from time to time (including but not limited to tickets or access to Boston Celtics games and/or events, Boston Celtics Online Store discounts, and Boston Celtics autographed items) (the “Boston Celtics Rewards”).

1. The use of all tickets, passes and suites in connection with Boston Celtics Rewards is subject to the ticket use terms (including terms printed on, or on the backs of, the tickets), rules, and regulations established from time to time by the Boston Celtics, Delaware North Companies, Inc. — Boston (“DNC-B”) (the owner of the TD Garden), and by the operator of any other arena in which a National Basketball Association (“NBA”) game is played or other relevant event is held (collectively, across all arenas, the “Ticket Rules”). In the event of any violation of the Ticket Rules, the Celtics and the relevant arena operator will have the right to revoke the tickets and eject the violators from the relevant arena. The Boston Celtics and/or NBA may cancel, postpone, reschedule or relocate games or events (collectively, “Events”) for any reason, as determined in their/its sole discretion, as well as to modify or discontinue, temporarily or permanently, any aspect of such Events.
2. Boston Celtics Online Store discounts may not be combined with any other coupon, discount, or offer. Discount has no cash value and cannot be redeemed for cash. Exclusions and/or additional terms may apply. Please see [Celtics.com/shop](#) for details.
3. Boston Celtics autographed items may not be used in any public promotion, giveaway, sweepstakes, or offer for sale, without the express written consent of the Boston Celtics.
4. Due to the uncertainty related to the novel coronavirus SARS-CoV-2 and any resulting disease (together with any mutation, adaptation or variation thereof, collectively, “COVID-19”), admission to any Event is subject to all safety and health requirements and policies put in place by the Boston Celtics, NBA, and arena or venue operator, including any requirements relating to facemasks and/or enhanced health screenings (which may include a requirement that the attendee, and any person in the attendee’s party, be tested for and/or fully vaccinated against COVID-19 prior to the Event), and applicable laws, requirements, and guidance. Such policies and requirements as they may be updated from time to time (in the sole determination of the Boston Celtics, NBA and/or arena or venue operator) and as they may be communicated to the attendee prior to or during the Event (whether orally or in writing) by, for example, instruction provided by arena or venue operator or arena or venue personnel or signage in or around the arena or venue, are collectively referred to below as the “Safety Requirements”. Event attendees must comply with the Safety Requirements (including all requirements that must be satisfied prior to or during the Event), and attendance at the Event is conditioned on such compliance. Event attendees may be required to agree to a standard waiver and release prior to attending a particular Event.
5. These Rules may be modified from time to time to reflect changes to the Boston Celtics Rewards and/or the Program. Any Rules modifications will be posted on this page and indicate the date on which the Rules were last revised.
